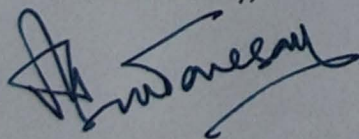
I take this opportunity to thank the promoters, my fellow directors, the management team, and all employees of the Company for their cooperation and support extended to me throughout my association with the Company.
